RE: Notice to the Minister under the *Navigation Protection Act* for review of a Dykes, located on the Peace River, unsurveyed portions of the bed of the Peace River lying SE of Section 16, TP 83, Range 19 West of the 6th Meridian Peace River District, in the Province of British Columbia

Our assessment of your work has determined that it is not likely to substantially interfere with navigation.

Therefore your work is permitted under section 9(1) – Construction, of the *Navigation Protection Act* (NPA) and you may proceed per the attached plan (1) in accordance with the following terms and conditions:

1. The NPA Approval and its Terms and Conditions shall be posted at an easily accessible place at the worksite.
2. In the event that the construction of the dam is terminated, it will be the owner's responsibility to remove the works and return the side channels to their original slope and riverbed elevations.
3. If vessel traffic is not blocked by booms, buoys or a patrol/escort boat and construction is not complete, the following conditions apply:
 - Install and maintain warning signs at locations approximately 100m upstream and downstream of the construction site on the main channel of the Peace River advising of the work in progress. Signs shall be a minimum of 72"x 48", a white background with black lettering, with text as outlined below. Sign to be emplaced prior to and for the duration of construction.

WARNING SIDE CHANNEL OBSTRUCTED AHEAD

- The outermost extent of the work above the surface shall be marked with orange Hi-visibility markers on the upstream and downstream corners.
- Construction machinery left in the Peace River during darkness or limited visibility shall be marked with a flashing yellow light, visible to upstream and downstream traffic
- Any construction equipment anchored or left in or on the Peace River shall be marked with a yellow flashing light placed on the outermost extremity if left overnight.

4. Proponent may use the Canadian Dam Association signage standards in regards to shape, colour and size. Locations and wording are to be as per the Terms and Conditions of the permit or approval.

Pursuant to Sec. 34 of the Navigable Protection Act, the owner shall provide unimpeded access to the Minister or their representatives for inspection purposes.

Pursuant to Sec. 5 of the Navigable Waters Works Regulations, all temporary piles, false works, silt curtains, construction material or debris, etc. are to be completely removed from the waterway.

Please note that permission relates only to the effect of your work on navigation under the NPA. It is the owner's responsibility to comply with any other applicable laws and regulations.
